

## Bevel King Door Warranty

Bevel King Doors is committed to providing products of only the highest quality. Therefore, we warrant our hardwood doors to be of good material and workmanship and to be free of defect for one (1) year warranty from the date of shipment, subject to the provisions stated herein. Our warranty protects against defects in workmanship and material that renders the product unfit for the purpose of which each door is recommended. Before leaving a Bevel King facility, your door has been inspected for any defects in materials and workmanship. All doors are shipped unfinished, and the natural movement of wood cannot be warranted. Each Bevel King door is meticulously packaged with care to ensure the door is protected in transit. Due to the nature of all hardwoods from which our doors are made, some discoloration and natural grain textures are considered acceptable.

This warranty shall be void if the unit has not been stored, installed, and maintained in a good and workmanlike manner, or if the damage is resulting from exposure due to installation in an unprotected opening, such as an installation without sufficient roof covering protection, which causes the door to be exposed to an unusual amount of direct sunlight and/or precipitation. The following conditions are not considered defects which are covered by the Bevel King Warranty: Wood doors are susceptible to expansion and contraction caused by temperature and humidity variations, therefore small surface checking, slight shrinking or cupping which may cause tiny cracks at the joints may occur; warp not exceeding ¼" for a 6'8" door measured across the plane of the door; warp not exceeding 3/8" for an 8'0" door across the plane of the door; no door taller than 8'0" shall be warranted, warp is defined as any distortion within the door itself, not pertaining to the relationship to the frame or jamb of the door, the term warp shall include bow, cup, and twist, in measuring a door for warp, the following method must be used, bow, cup and twist are measured by placing a straight edge, taut wire, or string on the suspected concave face of the door at any angle, the measurement of bow, cup and twist is made at the point of maximum distance between the bottom of the straightedge, taut wire or string to the face of the door; wood panel movement or shrinkage; any doors trimmed beyond ½" in the width and 1" in the height of the door; natural variations in the color of the wood or in the texture of the grain of the wood; doors which are hung improperly or do not swing freely; exterior doors not protected by substantial overhang or exposed to extreme weather conditions; damage resulting from any cause beyond the control of Bevel King including, but not limited to damage cause by misuse, abuse, accident, mishandling, fire, flood, earthquake, storm, tornado, or any other act of nature; any door that has not been sealed and finished the "same" on all 6 sides of the door, bore holes and mortise pockets and any other trimming of the door must be sealed and finished for this warranty to take effect; damage resulting from the installation of a storm door; leakage in the speakeasy opening in doors with this feature; rusting or metal deterioration or appearance of wrought iron; any defect from failure to perform regular annual homeowner maintenance.

All warranty claims must be presented as outlined above, within the warranty period for the specific product outlined above. Bevel King will not honor warranty claims made prior to payment in full for the warranted product. Upon validation by Bevel King of any claim, Bevel King will at its option:

- Repair the product, and return it FOB our Houston, TX facility or our Atlanta, GA. facility, freight collect.
- Furnish a comparable replacement product FOB our Houston, TX facility or our Atlanta, GA, freight collect.
- Refund the purchase price paid for the product by the original purchaser of the product from Bevel King.

Bevel King reserves the right to inspect any product, which is alleged to be defective. It may be deemed necessary for the product to be returned to the Bevel King facility in Houston or Atlanta for inspection. All freight costs to and from the appropriate Bevel King location necessary to process the warranty claim are the responsibility of the purchaser.

## Bevel King Triple Glaze IG Unit Warranty

Bevel King Doors is committed to providing products of only the highest quality. Therefore, we offer a limited five (5) year warranty from the date of manufacture on all Triple glazed (IG) insulated glass panels, subject to the provisions stated herein. Our warranty protects against permanent failure of the hermetic seal directly attributed to defective manufacturing, which failure results in permanent obstruction of vision through the panel. Bevel King does not warrant any product against glass breakage or glass damage for any reason. All beveled glass and textured glass panels are handmade. Therefore, some bubbles and imperfections are acceptable in the glass. On occasion movement of the bevels within the came may cause a slight rattle, this is a normal occurrence.

This warranty shall be void if the unit has not been stored, installed, and maintained in a good and workmanlike manner, or if the damage is resulting from exposure due to installation in an unprotected opening, such as an installation without sufficient roof covering protection, which causes the door and glass panel to be exposed to an unusual amount of direct sunlight and/or precipitation. The following conditions are not considered defects which are covered by the Bevel King Warranty: If the failure of the seal is caused by an Act of God; damage as a result of exposure to corrosive fumes or condensates; moisture formation between the glass panels that does not permanently and materially obstruct vision; condensation, frost, or mold resulting from humidity within the building, or resulting from interior/exterior temperature differentials; damage resulting from excessive stress from movement of the structure; glass distortion or breakage; scratches or other visual imperfections, unless observable from 48 inches from the product; mishandling or improper installation or by any other cause whatsoever not within our exclusive control; movement within the glass panel that does not affect the structural integrity of the product; movement of the door lite sealant onto the surface of the panel; glass panels covered by window film of any kind; damage resulting from the installation of a storm door. This warranty shall not apply unless the failure occurs, and claim is delivered to us within FIVE years after the date of manufacture of the insulated glass panel.

All warranty claims must be presented as outlined above, within the warranty period for the specific product outlined above. Bevel King will not honor warranty claims made prior to payment in full for the warranted product. Upon validation by Bevel King of any claim, Bevel King will at its option:

- Repair the product, and return it FOB our Houston, TX facility or our Atlanta, GA. facility, freight collect.
- Furnish a comparable replacement product FOB our Houston, TX facility or our Atlanta, GA, freight collect.
- Refund the purchase price paid for the product by the original purchaser of the product from Bevel King.
